2. Review and Approve Minutes of February 1, 2011

Selectman Allaire moved to accept the Minutes of February 1, 2011 as written, Selectman Drew seconded a motion. Vote, 3-0-1

4. Unfinished Business:

A. FY12 Budget: Budget Committee Recommendations for Budget

Dwayne presented a memo from MMA to the Board of Selectmen regarding the impact to municipalities from Governor LePage's proposed budget on the subject matter of Revenue Sharing, General Assistance and Education.

Dwayne updated the Board on the Budget Committee recommendations for FY12 Budget thus far.

Selectman Drew moved that this issue will not be addressed on the Warrant, Selectman Folsom seconded a motion. Vote, 4-0

Selectman Drew moved that the Board declines the approval of \$4,000.00 to repair Bauneg Beg Dam, but will be placed before the Budget Committee to go to Town Meeting, Selectman Folsom seconded a motion. Vote, 4-0

B. Assessing: Update Sales Analysis

The Town Assessor explained in a letter to the Board of Selectmen that the sales ratio study has been returned to the Maine Revenue Service in order that they are able to complete the annual sales ratio study audit. The preliminary number indicated a combined ratio for North Berwick of approximately 100%.

The sales ratio is used to determine reimbursement for exemption programs and for this year used sales from July 1 2009 through June 30, 2010. The impact of the ratio study is also reflected in determination of the 2012 State Valuation.

D. Committee Appreciation: Dinner Menu, Program and Cost Review

The Board of Selectmen was in agreement with the Dinner Menu, Program and Cost for the Appreciation Dinner.

E. FY12 Referendum: Pace Ordinance, Medical Marijuana, Zoning Changes
