#### Town of North Berwick, Maine Fee Schedule

The Town of North Berwick Board of Selectmen will be holding a Public Hearing on Tuesday, June 7, 2011 at 6:35 p.m. at the Municipal Office Conference Room for a public hearing on the Town of North Berwick schedule of fees. This Public Hearing is being held pursuant to Article 1.5.6 of the North Berwick Zoning Ordinance. A copy of the proposed fee schedule is available in the Town Clerk's Office and on the Town of North Berwick website – www.townofnorthberwick.org

Dwayne explained the draft Fee Schedule for the coming year. There are a few changes that are being proposed to the Fee schedule relating to Zoning, Building or Plumbing. These fees are dictated by State Law and the Town Ordinance.

In order to purchase a Zoning Ordinance copy the Town will charge at their cost \$20.00 a free download is available on the North Berwick's website.

The Planning Board's Conditional Use Permit cost is \$50.00.

To apply for a Variance from the Zoning Board of Appeals we are proposing to increase the cost to \$100.00.

The Plumbing Permit is set by the State and the fees are \$10.00 per fixture.

The Town has added a double cost fee for work that is started without a permit.

The State has stated that the Town has to charge for Septic Systems.

The only other change we are currently looking to change the Building Permit to \$6.00 per \$1,000.00 of Estimated Completed Value and \$5.00 filing fee.
