The Board of Selectmen reviewed the State Dam inspector findings report with the recommendations.

The State Dam inspector considered the dam a low potential hazard dam.

Dwayne explained that in the State inspector report that the dam is not designed to take 100 or 500 year storms. A 10 year storm will over top the dam. The State inspector recommended adding a foot of cover on top of the dam between the spillway gate and the spillway itself and opens up the spillway so that it actually handles a 100 or 500 year storm. At this time the dam will handle 700 cubic feet of water.

The Bauneg Beg Lake Association received bids of \$20,000.00 to repair the dam.

The Bauneg Beg Lake Association is actively raising funds in order to repair the dam.

Dwayne asked the Bauneg Beg Lake Association to put together a complete proposal for the Board of Selectmen to review.
