2. Review and Approve Minutes of October 19, 2010

Selectman Drew moved to accept the Minutes of October 19, 2010, Selectman Folsom seconded a motion. Vote, 4-0

3. Public Hearing: 6:35 p.m. – General Assistance Appendices

Selectman Folsom opened the Public Hearing for General Assistance Appendices at 6:35 p.m., Selectman Drew seconded a motion. Vote, 4-0

Selectman Drew closed the Public Hearing for General Assistance Appendices, Selectman Folsom seconded a motion. Vote, 4-0

5. Unfinished Business:

A. Roads and Maine Community Foundation Grant: Update

Road construction in North Berwick has been completed.

The third week of November the placement of the shoulders will be placed on Oak Woods Road.

Pike Inc. will be providing a truck for the Town to utilize to place shoulders on Oak Woods Rd.

The Town Crew has completed winter sand.

Due to the storm the Town Crew will be placing a culvert at the end of Maple Street and Governor Goodwin Road and pave where the road was washed out.

The Town received \$5,000.00 from Federal Government to place a culvert on Lebanon Road.

Selectman Drew moved to authorize the funds to do the project on Little River Road from the Road Account, Selectman Folsom seconded a motion. Vote, 5-0

The new light pole has been completed and all lights are now working.

The plaque has been installed on the Island Garden light pole.

B. Election Results: Sign SAD 60 Warrant, Ballot Clerks for Dec. 7, Vote

Dwayne explained that the discontinuance had failed the numbers for the State Referendum was switch from the Town Referendum and it passed overwhelmingly 1400 to 460. The Town Attorney will be working on deed transfer. The Town Clerk has sent in the discontinuance to the Registry of Deeds and will be deeded to the property owners.

Dwayne explained that before the Board of Selectman is a Warrant for Maine School Administrative District to revote on the Bond Referendum from 3:00 p.m. to 7:00 p.m. on December 7, 2010.

A. General Assistance: Review and Approve New Appendices

C. Parks and Rec: Application for Membership – Brina Paquette, Beau Lambert, Terri Raftery

Selectman Folsom moved to accept Brina Paquette for the Parks and Recreation Commission, Selectman MacDougall seconded a motion. Vote, 5-0

Selectman Folsom moved to accept Beau Lambert to the Parks and Recreation Commission, Selectman MacDougall seconded a motion. Vote, 5-0

Selectman Folsom moved to accept Terri Raftery to the Parks and Recreation Commission, Selectman MacDougall seconded a motion. Vote, 5-0

Richard Reynolds asked the Board to explain the importance of the Parks and Recreation Commission Board.

Dwayne discussed that the Town amended the Bylaws of the Commission back approximately four years ago. The Parks and Recreation Commission is basically an advisory committee to assist the Parks and Recreation Director to put forth programs and ideas and events for the Town to consider.

Selectman Folsom asked if there were minutes taken at the meetings.

Kristie Michaud answered yes, and I take notes.

Selectman Folsom asked that the Board of Selectmen review the minutes so that we are aware of the events for Parks and Recreation.

Selectman Drew suggested an agenda be placed on the Town's Website for Parks and Recreation.

Kristie Michaud the Parks and Recreation Director discussed having students from Town to come to meetings per request to see if they would be interested in certain events that the Parks and Recreation would like to provide. For example: if we had a dodge ball tournament would they be interested. We would like to have a student from each school provide input for events.

D. SAD 60: Review Applications for Interim Member Position

E. Dispatch: Appoint Representative and Alternate to Communication Board

Selectman Drew moved that the Police Chief appoint a representative he chooses to the Communication Board and the Fire Chief appoint a representative he chooses to the Communication Board, Selectman MacDougall seconded a motion. Vote, 5-0

F. Bauneg Beg Lake Association: Request for Funding for Dam Repair

Dwayne explained that Bauneg Beg Association is requesting from the Town of North Berwick and the Town of Sanford \$4,000.00 for repairs for the Bauneg Beg Dam. The Town of North Berwick would need to place a Warrant for Town Meeting in April.

Selectman Drew moved that the money solicited for Bauneg Beg Lake Association of \$4,000.00 will be a Warrant Article on the next budget cycle Town Meeting approval, Selectman MacDougall seconded a motion. Vote, 5-0

G. Fire Department: Substation Repairs – Mold Issues

Dwayne discussed with the Board of Selectman regarding the mold at the Fire Department on Morrells Mill Road.

Dwayne asked for authorization to start with the renovation of the bathroom project.

Selectman Folsom moved to accept Cliff Foster's bid for \$2,522.00 with funds from the Emergency Building Funds, Selectman Drew seconded a motion. Vote, 5-0

Dwayne will provide the Board with the costs for the rest of the renovations needed at Fire Department on Morrells Mill Road at the next Board of Selectmen's meeting.

H. Gifts: Accept Funds on Behalf of Fire Department and Police Department

Dwayne explained that the Town received two gifts; one is for the Fire Department from Star Hill Riders for \$200.00 and for the Police Department from the Seacoast Trail Riders for \$2,000.00.

Selectman Folsom moved to accept funds for the Fire Department for \$260.00 and the Police Department for \$2,000.00, Selectman MacDougall seconded a motion. Vote, 5-0
