NORTH BERWICK BOARD OF SELECTMEN MINUTES MAY 19, 2009

Chairman Folsom opened the Board of Selectmen's Meeting at 6:30 p.m.

1. Pledge of Allegiance

2. Review and Approve Minutes of May 5, 2009

Selectman Drew moved to accept the Minutes of May 5, 2009 as written, Selectman Bourbon seconded a motion. Vote, 4-1

3. Public Input: No Public Input

4. Unfinished Business:

A. Dispatch: Discussion on Dispatch Services

Dwayne discussed with the Board that the Town is working on dispatch services.

The Town has tested out frequencies for the FCC.

The Town has finalized the agreement with IMC dispatch transfer.

The concern remains that the Police Department cruiser portables can communicate with dispatch.

The Town will order the equipment that will be housed in the communication shed.

B. Ice Storm: (moved) Tree Debris Clean Up

A Newsletter will be sent out on May 21, 2009 informing the residents that beginning the week of June 1, 2009 the Town of North Berwick will be conducting a roadside clean up of the wood debris that was a result of the Ice Storm of December, 2008.

Residents may bring their Ice Storm wood debris within the right-of-way for clean-up prior to June 1, 2009.

The week of June 1st the North Berwick Town Crew along with J.T. Cotty Tree Work, Abbott Hill Tree Service, and Chain Saw Steve will be conducting road debris clean-up.

Oakwoods Lumber granted the Town permission to allow residents to bring their wood debris to their facility located on the corner of Valley Road and Oak Woods Road. The hours of operation are Monday – Friday from 8:00 a.m. – 3:30 a.m. and Saturday from 8:00 a.m. to 11:30 p.m.

Residents may obtain a Burning Permit from the North Berwick Fire Department. (207-676-2611)

C. Me. Community Foundation: Review Project Ideas for Grant Submission

Dwayne spoke with Maine Community Foundation and gave them the list of proposed projects.

Maine Community Foundation asked for a written proposal from Dwayne.

When Maine Community Foundation has received the proposal from Dwayne they will begin reviewing the proposed projects for the Town of North Berwick.

D. Farmer's Market: Discussion on the proposed North Berwick Farmer's Market

A concern that has come up with the North Berwick Farmer's Market is the hours of operation of the market and parking near the entrance of the Municipal Building. This may conflict with the Municipal Building business hours.

The North Berwick Farmer's Markets would prefer a shaded area but will move the market to the lower end of the parking lot as it will interfere with the Municipal Building business hours of operation.

The North Berwick Farmer's Markets will attend the Board of Selectmen's Meeting on June 2, 2009.

E. Cemetery Trustees: (moved) Discussion on proposed Easement for Crematory at Hillside Cemetery – Executive Session 1MRSA 405 (6)(C)

Selectman Bourbon moved to go into Executive Session 1MRSA 405 (6)(C) at 7:24 p.m., Selectman MacDougall seconded a motion. Vote, 5-0

Chairman Folsom closed Executive Session 1MRSA 405 (6)(C) at 8:00 p.m.

Selectman Danforth spoke that he wanted to disclose publicly that he was asked Mike Johnson Jr. to put together the site plan for the crematory and though we have not formally entered an agreement, I do see that forth coming.

Dwayne explained that Mr. Johnson's Attorney put together an agreement that he wanted us to review. We sent it to our Town Attorney and our Attorney had some issues with some of the agreement.

The Town Attorney has made recommendations to the proposed Crematory at Hillside Cemetery. The Town Manager and the Board of Selectmen would like to have those recommendations redrafted into the proposed Crematory at Hillside Cemetery agreement.

The Board asked that Dwayne have Town Attorney move forward with the recommendations to the proposed agreement for Crematory at Hillside Cemetery.
