#### A. Roads: Update

Sid Hall Drive will be paved on September 16, 2009.

The Town Crew is anticipating finishing the side walk on Canal Street on September 17, 2009.

Portland Street project may be on hold until the next spring.

#### **5. New Business:**

#### A. SAD#60: (moved) Discussion: with Superintendent Regarding Bond Proposal

Superintendent Paul Andrade discussed with the Board of Selectmen a 15-year bond package of \$571,550 that will be presented to voters at the November 3, 2009 election. This bond proposal is at zero interest. The annual bond payment will be \$38.103 and will be incorporated into the district budget

The federal stimulus package known as the American Recovery and Reinvestment Act created a new program called Qualified School Construction Bonds. Qualified School Construction Bonds are tax credit bonds which can be used for the construction or repair of public school buildings. Lenders receive tax credits from the Federal government instead of interest payments from school administrative districts. School districts are only responsible for repayment of the bond principal and thus have the opportunity to borrow funds at zero interest. M.S.A.D. #60 is one of only 13 districts in the state approved for this funding by the Maine Department of Education. This is a one time stimulus program so we may never again have a chance to repair our buildings at such a low cost. Utilizing this program saves the district \$139,000 in interest versus a bond at 4.5% percent. Repairs will be done at the Lebanon Elementary School, Hanson School, North Berwick Primary School and the Mary Hurd School.

Selectman Drew moved that the School Warrant be placed on the Referendum, Selectman Danforth seconded a motion. Vote, 3-0

#### **B. Planning Board:** (moved) Interview of Patrick Raftery, Review Julie Morse-Patuleia

The Board of Selectmen interviewed applicant Patrick Raftery for a position on the Planning Board. Mr. Raftery will attend a Planning Board meeting on September 24, 2009 and decide if he wants to serve as a member.

The Board of Selectmen will interview applicant Julie Morse-Patuleia for a position on the Planning Board on October 20, 2009.

#### C. Commitment FY10: (moved) Abatement and Supplementals, Sign Municipal Valuation
