2. Review and Approve the Minutes of September 2 and September 9, 2008

3. Public Input

4. Unfinished Business:

A. Roads: Update on Progress

Linscott Road has been stumped, ditched and was reclaimed on September 16, 2008.

After Linscott Road is complete the road crew will move to Nowell Street.

B. Comprehensive Plan: Submission Documents to the State

At the Public Hearing last Tuesday night a member of the Comprehensive Plan Committee requested that an appendix be added to the Comprehensive Plan. The appendix explained sections that were deleted from the Plan.

The Board discussed portions of the plan that could be reinserted into the plan with some editing.

Selectman Whitten moved not to attach the appendix to the document, Selectman Folsom seconded a motion. Vote, 4-0

Selectman Whitten moved to include into the Comprehensive Plan asking Dwayne to edit the text as to make the sections not binding, reference to Appendix A. in the Boards packet, number 3, 4, 5, 6, 7, and 8,

3. Encourage the State to waive plumbing fixture fees for businesses that install showers for their employees since lack of showers at work has been cited as a major disincentive for employees biking to work; or find other ways to give incentives to businesses to provide showers for their employees,

4. Work with the Sanitary District to clarify under what conditions sewer hook-up can be made available within the current sanitary district,

5. Encourage a policy of non-idling school buses and trucks in town as one way to lower our carbon footprint town-wide and decrease air pollution; LED Street lights may be another mitigating option,

6. Encourage the schools to investigate the development of centralized pick up and drop off locations for commuting children,

7. Assist school to determine barriers to school bus ridership and develop incentives to ride the bus, bike, or walk,

8. Work with the town and the schools to encourage purchasing food from local farmers in public town events and in school food programs,

Selectman Bourbon seconded a motion. Vote, 3-1

C. Public Works: Update on Replacement of Diesel Tank

Dwayne informed the Board that the Town received their diesel tank permit.

D. Mill Field: Electrical Service Issue

There is an electrical service issue on where to place the electrical box so that it can be seen and unify with the Gazebo.
