A. James & Marianne Benedict--- Applicant proposes to expand a non-conforming structure within the Resource Protection District, One Dormer and Two Porches. (Map 2, Lot 20-1) 166 High Street.

Lawrence Huntley, CEO explained that the Benedict's are within the Resource Protection Zone. They are not in the Shoreland Zone.

Article 1.4.5 Non Conforming Structures:

- a. Enlargement Controlled: A non-conforming structure shall not be added to or enlarged unless:
- (1) Such addition or enlargement conforms to all the regulations now in effect for the zone in which it is located:

6.9.6 Factors Applicable to Conditional Uses

- d. Special Exceptions. In addition to the criteria specified in Section 6.9.6 (c) above, excepting structure setback requirements, the Planning Board may approve a permit for a single family residential structure in a Resource Protection District provided that the applicant demonstrates that all of the following conditions are met:
- (1) There is no other location on the property, other than a location within the Resource Protection District, where the structure can be built.

In this case there is no other spot because the whole land is within the Resource Protection Zone. A Conditional Use is required to allow that expansion.

The Benedict's want to add a porch extended toward the road which will decrease their front setback and will have to go before the Zoning Board of Appeals for a 20% variance, but only if Planning Board approves the Conditional Use Permit.

Barry Chase moved to approve the Conditional Use Permit for James and Marianne Benedict, Julie Fernee seconded a motion. Vote 3-0
