1. Call to Order:

Chairman R. Todd Hoffman opened the Planning Board Meeting at 6:32 p.m.

2. Current Business:

A. Central Maine Power Co. ---Applicant proposes to add a definition for "electric power transmission and related equipment" to the Zoning Ordinance.

Lawrence Huntley, CEO explained to the Board that the Town Attorney recommended a change to the Zoning Ordinance :(Table 4.3 - this ordinance)

Article 3 Definitions:

Electrical power transmission or distribution lines and related equipment. Such systems are a form of essential service and may include towers, poles, wires, cables, and similar accessories, but shall not include service drops or building which are necessary for the furnishing of such services. Notwithstanding the height limitations in Table 4.3 this ordinance the maximum height for transmission towers located within or adjacent to an existing transmission corridor is 110 feet.

Shaun DeWolf moved to accept the Electrical power transmission or distribution lines and related equipment to the Zoning Ordinance as written, Chris Karcher seconded a motion. Vote, 4-0

B. U.S. Cellular (KJL Wireless) --- Conditional Use Permit, applicant proposes a communications facility on Schoolhouse Road. (Map5, Lot 37A)

Julie Fernee moved to reconsider U.S. Cellular application, Chris Karcher seconded a motion. Vote, 4-0

Chairman R. Todd Hoffman spoke that we here this evening to confer in open public session what was discussed in executive session on October 22, 2009 so that it is no longer privileged.

Chris Karcher spoke that what we were doing was discussing procedure of the evening.

Shaun DeWolf spoke that the discussion in executive session was Planning Board procedure of the evening.
